#### **Future of our Greens**

So, let me start this newsletter with some really lovely news......John Bohner has been appointed for a further 4 years as our Greenkeeper. Congratulations John!

As you know, we have had a committee of **Ian Campbell, Paul White, Tony Myles and myself** looking at the Future of our Greens given John's term was up at the end of June. The committee compiled a full report for the Board on the advantages and disadvantages of using contractors, a greenkeeper or the feasibility of installing artificial turf. Special thanks to the committee for their hard work.

The final report is quite long and detailed, so you will find an Executive Summary attached along with the recommendations to the Board from the committee. The recommendations were accepted unanimously. I do urge you to read the summary because you will see that we face quite a unique situation on our greens with both soil movement on the western side of the greens and the complex nature of the pathogens and soil/root abnormalities in all greens. We are very fortunate also to now be working with a company called *Living Turf* for the latter problem.

We are intending to have a brief information session on **Wednesday June 20** at the special meeting to ensure that all members are fully informed about the review undertaken by the committee. The full report will also be made available.

The further good news is that BBC now has a comprehensive document detailing the makeup of our greens which I'm sure will be put to good use in the future.

#### **Special Meeting**

Please come along to our **Special Meeting** on **Wednesday June 20 at 7pm**. A motion has been sent out detailing the expenditure we are seeking approval for to complete the upgrade of our lounge and bar and perhaps a few things in the hall.
